Processing Information

The processor removed all metal fasteners and replaced them with plastic paper clips. The documents arrived in separate envelope, labeled by court term. The processor transferred the documents to acid free folders and containers, printing the envelope information on the folders verbatim. Some documents are ripped and there is a considerable amount of dirt. Excess dirt was removed, but most of the documents have been stained by its presence. Oversized documents were removed,

along with all other documents within the envelope box, and put into a special acid free box for large documents.

This collection contains the records of the Commissioner's Court from 1915-1918. The Commissioner's Court was the forerunner to the current County Commission. These records reflect all of the business conducted by the Commission between 1915 and 1918.

Arrangement

The processor preserved the original order of the documents. They are arranged by Court Term and Year. Special court terms, such as adjourned terms, often occur in a later month. The processor filed these special cases under the term listed, the month in which the court session occurred.
