II. **Approval of Minutes** – A motion to approve the minutes of the June LEPC Quarterly Meeting was made by John Frank. A second provided by Teresa Porter. The minutes were approved as presented.

III. **Presentation** – Deann Servos, Prodissee Pantry, provided a presentation on the activities and holiday preparation for assisting families. Deann announced the next Connecting Communities Luncheon will be on Thursday at Prodissee Pantry in Spanish Fort.

V. **Committee Reports**

- **Finance Committee:** Finance Report - presented by Jenni Guerry, Secretary/Treasurer: The LEPC account balance was reported as \$16,428.41.
- **Shelter Committee:** Scott Wallace reported that Longs has been contracted to provide employment services for shelter workers. There have been no changes to the shelter locations designated in the county.
- **Health Committee:** Teresa Porter, ADPH, updated the LEPC members on the Baldwin County Medical Health Committee. This is the Baldwin Health Preparedness Group that is part of the Area Healthcare Emergency Response Coalition (HERC). Teresa encouraged partners from the medical community and EMS to participate in this committee. ADPH is continuing Strategic National Stockpile planning and preparedness as well as Closed Points of Dispensing (POD) recruitment. Teresa also reminded the committee that flu season is quickly approaching and that there are numerous positive flu cases in our region. Teresa encouraged everyone to obtain their flu shot this year.
 - Peggy Lassiter with the Medical Reserve Corp (MRC) discussed the volunteer orientation held last week for the volunteers. The MRC will be working with Prodissee Pantry for the Turkey Trot 5K Fundraiser event. Peggy described the continued progress

with securing MOU's with Baldwin County EMA for cooling/breathing treatment/electrical support locations for post disaster needs.

- **Law Enforcement:** Al Lugo, Foley PD, announced the Gospel Festival scheduled for Saturday, October 3rd at the Foley Soccer Complex. This event is raising money for the Care House and the Lighthouse for Baldwin County. The "Dia de la Raza" Hispanic Heritage Event will be held at Heritage Park in Foley on Sunday, October 18th from 9am-5pm. Al also announced the Drug Take Back program that will be sponsored by the Police Department at the local Foley Wal-mart in October.
- **Fire Service** – Chief Joey Darby discussed the recent Orange Beach Cotton Bayou Condo fire in which mutual aid was requested from surrounding jurisdictions. Foley is nearing completion on the new fire station and are in process of hiring for vacant positions. Foley Fire Department recently responded to a mobile home fire in which a Hispanic Family was displaced and Chief Darby explained how the American Red Cross assisted with the family housing.
- **VOAD** – no report
- **EMA Update:** Reggie Chitwood, Director BCEMA, discussed the education outreach efforts conducted by EMA, including Delta Dash, the County Fair, Gospel Fest and other supported events. Reggie talked about continuing recovery efforts and coordination with the Navy for use of outlying airfields for staging areas following a disaster. The Community Assessment Survey for Public Health Preparedness (CASPER) conducted by CDC and ADPH was completed and results will be presented to the commission during the next Baldwin County Commission Meeting. Melissa Morrison has been requested to also provide this presentation for the December LEPC full body meeting in December. EMA social media continues efforts in September for the month of preparedness with various Public Service announcements (PSA's), tweets, and posts. Reggie encouraged membership to like and follow Baldwin County EMA on facebook and twitter.
 - Scott Wallace, Training officer for EMA, announced the upcoming ICS courses and storm spotter classes. Please visit www.baldwincountyal.gov/departments/ema and visit the training calendar for more information and registration. Scott announced that TEEX will be conducting a Medical Management for Bombing Incidents on Feb. 23-24, 2016 at Poarch and a PIO course in March of 2016 which will be held at the EOC.

 - Andrea Blair and Donna Stallworth, Addivant, provided an introduction and brief description of plant activities to the committee. The LEPC welcomed industry participation and encouraged future attendance.
