### CHANGES TO BALDWIN COUNTY VOTING PRECINCTS

In accordance with applicable Alabama Law, please be informed that the Baldwin County Commission, during its January 16, 2018, regular meeting, adopted Resolution #2018-043 which approved certain voting changes applicable to Baldwin County, as follows:

# 1) DIVISION OF EXISTING VOTING PRECINCTS TO CREATE ADDITIONAL, NEW VOTING PRECINCTS AND DESIGNATION OF VOTING LOCATIONS FOR THE NEWLY CREATED VOTING PRECINCTS

a) Authorized the division of Voting Precinct No. 38 (Foley) into two precincts, said division creating a new Voting Precinct No. 47 (Foley West) and designating Foley United Methodist Church, located at 915 North Pine Street, Foley, Alabama 36535, as the Voting Place for said new Voting Precinct No. 47.

[Current Precinct No. 38 will be split along State Highway 59, with the west portion of the Precinct being designated as a new Precinct No. 47 (Foley West) and the east portion of the Precinct remaining as Precinct No. 38 (Foley East). The Foley Civic Center will remain as the polling place for Precinct No. 38 (Foley East).]

**b)** Authorized the division of Voting Precinct No. 39 (Gulf Shores) into two precincts, said division creating a new Voting Precinct No. 48 (Gulf Shores North) and designating Gulf Shores Cultural Center, located at 19470 Oak Road W., Gulf Shores, Alabama 36542, as the Voting Place for said new Voting Precinct No. 48.

[Current Precinct No. 39 will be split along the Intracoastal Canal, with the north portion of the Precinct being designated as a new Precinct No. 48 (Gulf Shores North) and the south portion of the Precinct remaining as Precinct No. 39 (Gulf Shores South). The Gulf Shores Meyer Civic Center will remain as the polling place for Precinct No. 39 (Gulf Shores South).]

c) Authorized the division of Voting Precinct No. 42 (Fairhope) into two precincts, said division creating a new Voting Precinct No. 49 (Fairhope East) and designating Fairhope Avenue Baptist Church, located at 8717 Fairhope Avenue, Fairhope, Alabama 36532, as the Voting Place for said new Voting Precinct No. 49.

[Current Precinct No. 42 will be split along State Highway 98 south of State Highway 104, with the east portion of the Precinct being designated as a new Precinct No. 49 (Fairhope East) and the west portion of the Precinct remaining as Precinct No. 42 (Fairhope West). The Fairhope Civic Center will remain as the polling place for Precinct No. 42 (Fairhope West).]

### 2) REALIGNMENT OF VOTING PRECINCT BOUNDARIES

- a) Authorized the realignment of the boundaries of Voting Precinct No. 6 (Bromley) and Voting Precinct No. 18 (Stapleton), said realignment taking into Voting Precinct No. 18 certain limited areas of Voting Precinct No. 6.
- **b)** Authorized the realignment of the boundaries of Voting Precinct No. 11 (Lottie) and Voting Precinct No. 12 (Stockton), said realignment taking into Voting Precinct No. 12 certain limited areas of Voting Precinct No. 11.
- c) Authorized the realignment of the boundaries of Voting Precinct No. 28 (Lillian) and Voting Precinct No. 32 (Elberta), said realignment taking into Voting Precinct No. 32 certain limited areas of Voting Precinct No. 28.
- **d)** Authorized the realignment of the boundaries of Voting Precinct No. 29 (Perdido Beach) and Voting Precinct No. 32 (Elberta), said realignment taking into Voting Precinct No. 32 certain limited areas of Voting Precinct No. 29.
- e) Authorized the realignment of the boundaries of Voting Precinct No. 31 (Summerdale) and Voting Precinct No. 47 (Foley West), said realignment taking into Voting Precinct No. 47 certain limited areas of Voting Precinct No. 31.
- f) Authorized the realignment of the boundaries of Voting Precinct No. 33 (Miflin), Voting Precinct No. 38 (Foley East), and Voting Precinct No. 48 (Gulf Shores North), said realignment taking into Voting Precinct No. 38 and Voting Precinct No. 48 certain limited areas of Voting Precinct No. 33.
- g) Authorized the realignment of the boundaries of Voting Precinct No. 38 (Foley East) and Voting Precinct No. 32 (Elberta), said realignment taking into Voting Precinct No. 32 certain limited areas of Voting Precinct No. 38.
- **h)** Authorized the realignment of the boundaries of Voting Precinct No. 35 (Daphne) and Voting Precinct No. 20 (Daphne North), said realignment taking into Voting Precinct No. 20 certain limited areas of Voting Precinct No. 35.

- i) Authorized the realignment of the boundaries of Voting Precinct No. 35 (Daphne) and Voting Precinct No. 23 (Belforest), said realignment taking into Voting Precinct No. 23 certain limited areas of Voting Precinct No. 35.
- **j)** Authorized the realignment of the boundaries of Voting Precinct No. 36 (Magnolia Springs) and Voting Precinct No. 47 (Foley West), said realignment taking into Voting Precinct No. 47 certain limited areas of Voting Precinct No. 36.
- **k)** Authorized the realignment of the boundaries of Voting Precinct No. 43 (Fairhope, 3 Circle Church), Voting Precinct No. 44 (Barnwell), and Voting Precinct No. 49 (Fairhope East), said realignment taking into Voting Precinct No. 44 and Voting Precinct No. 49 certain limited areas of Voting Precinct No. 43.

#### 3) RELOCATION OF VOTING PLACES

- a) Relocated the voting place for Voting Precinct No. 3 (Vaughn) from the Vaughn Community Center to the Old Vaughn School, located at 55260 County Road 21, Stockton, Alabama 36579.
- **b)** Relocated the voting place for Voting Precinct No. 9 (Loxley) from the Loxley Town Hall to the Loxley Civic Center, located at 4198 Municipal Park Drive, Loxley, Alabama 36551.
- c) Relocated the voting place for Voting Precinct No. 25 (Robertsdale) from the Robertsdale City Hall to the PZK Hall, located at 17933 State Highway 104, Robertsdale, Alabama 36567.
- **d)** Relocated the voting place for Voting Precinct No. 26 (Elsanor) from the Elsanor Community Center to the Bethel Baptist Church, located at 22250 US Highway 90, Robertsdale, Alabama 36567.
- e) Relocated the voting place for Voting Precinct No. 33 (Miflin) from the Miflin Community Center to the Graham Creek Interpretive Center, located at 23030 Wolf Bay Drive, Foley, Alabama 36535.
