

THE ALABAMA DEPARTMENT OF PUBLIC HEALTH COVID-19 MASS VACCINATION CLINIC AT THE DAPHNE CIVIC CENTER

The Alabama Department of Public Health (ADPH) is the lead agency for the COVID-19 mass vaccination initiative. The Baldwin County Emergency Management Agency (BCEMA) and the City of Daphne are working together to coordinate the support for the vaccine initiative. Due to the limited vaccine supply, ADPH has delineated a phased approach to vaccine distribution to the members of the community.

On Tuesday, January 19, ADPH will begin making COVID-19 vaccinations available in Baldwin County to people 75 years or older, and first responders, including law enforcement and firefighters. ADPH is working to expand access to other groups within 1b. The vaccine that will be administered at the Baldwin County mass vaccination site is the Moderna vaccine. Individuals who want to receive the vaccine must provide identification, and complete necessary consent forms before the vaccine is administered. They will be observed by a medical professional for approximately 15-minutes before leaving the vaccination clinic. For individuals who may have functional access needs or ambulatory challenges, accommodations will be made with drive-thru options at the Daphne Civic Center. Residency in Alabama is not a requirement. This clinic will operate on a first come, first served basis. Appointments are not taken for this clinic. Face masks and social distancing measures are required. It is anticipated that clinics will continue to be conducted in coming months for more eligible groups added as additional vaccine is made available.

Moderna COVID-19 Vaccine: This vaccine is authorized for emergency use in individuals aged 18 years and older and will be administered at the mass vaccination clinic. This is a two-dose vaccine, given 28-days apart. Clinical trial data shows the vaccine is about 94% effective after two doses. No serious safety concerns were found. Individuals receiving their first dose of the vaccine will be given a date and time to return for the second dose.

Most common side effects and safety information:

In arm where shot was administered:	Throughout the rest of the body:
Pain	Chills
Swelling	Tiredness
Redness	Headache

These side effects usually start within a day or two of getting the vaccine. They might feel like flu symptoms and might even affect your ability to perform daily activities but should subside within a few days.

The mass vaccination clinics will be held at the **Daphne Civic Center, 2603 US-98, Daphne, AL 36526**. The dates and times are listed in the chart below. Additional information on clinic dates for February and March will be forthcoming. Please **DO NOT** contact the City of Daphne or the Daphne Civic Center for details about this clinic. **Vaccinations will be administered while supplies last. Please DO NOT line up prior to 6:30AM.**

Daphne Civic Center 2603 US-98 Daphne, AL 36526	01/28/2021	9:00am-3:00pm	On-site registration is required. Gates open at 6:30AM. Vaccinations will begin at 9:00AM. This clinic is for all healthcare workers, people 75 years or older, first responders, including law enforcement and firefighters only.

*A note for those who received their first dose of vaccine at the Robertsdale Health Department: An allotment of vaccine has been set aside for second doses. These will be kept separate from the vaccine that will be distributed to those receiving their first dose to ensure that those who received the first dose of vaccine will receive their second dose within the required time frame. A COVID-19 Vaccination Record Card will be required in order to receive a second dose.
