**CHANGES TO BALDWIN COUNTY VOTING PRECINCTS**

In accordance with applicable Alabama Law, please be informed that the Baldwin County Commission, during its February 1, 2022, regular meeting, adopted Resolution #2022-055 which approved various changes in Baldwin County Voting Precincts, as follows:

**1) REDEFINING AND MODERNIZING THE DESCRIPTIONS OF THE STANDARD CENSUS UNITS UTILIZING THE MOST RECENT 2020 CENSUS DATA**

Authorize the redefining and modernizing the descriptions of the standard census units [i.e. U.S. Census Bureau - GEOID Blocks] which describe the physical boundaries of each Baldwin County Voting Precinct, by utilizing the most recent data available by the Bureau of the Census of the United States Department of Commerce (2020 Census) and based upon criteria established and recognized by the U.S. Census Bureau for purposes of defining standard census units.

**2) REALIGNING EXISTING VOTING PRECINCT BOUNDARIES**

**a)** Authorize the realignment of the boundaries of Baldwin County Voting Precinct No. 4 (Crossroads) and Voting Precinct No. 15 (Bay Minette), said realignment taking into Baldwin County Voting Precinct No. 15 certain limited areas of Baldwin County Voting Precinct No. 4.

**b)** Authorize the realignment of the boundaries of Baldwin County Voting Precinct No. 7 (Spanish Fort East) and Voting Precinct No. 45 (Spanish Fort West), said realignment taking into Baldwin County Voting Precinct No. 45 certain limited areas of Baldwin County Voting Precinct No. 7.

**c)** Authorize the realignment of the boundaries of Baldwin County Voting Precinct No. 23 (Belforest) and Voting Precinct No. 43 (Fairhope, 3Circle), said realignment taking into Baldwin County Voting Precinct No. 23 certain limited areas of Baldwin County Voting Precinct No. 43.

**3) CONSOLIDATION OF EXISTING VOTING PRECINCTS**

**a)** Authorize the consolidation of Baldwin County Voting Precinct No. 3 (Stockton, Vaughn) and Voting Precinct No. 12 (Stockton, Civic Center), with numerical description for the consolidated precincts being designated as Voting Precinct No. 12 and designating the Stockton Civic Building, located at 54060 State Highway 59, Stockton, Alabama, as the Voting Place for said Voting Precinct No. 12.

**b)** Authorize the consolidation of Baldwin County Voting Precinct No. 8 (Loxley, Ellisville) and Voting Precinct No. 9 (Loxley, Civic Center), with numerical description for the consolidated precincts being designated as Voting Precinct No. 9 and designating the Loxley Civic Center, located at 4198 Municipal Park Drive, Loxley, Alabama, as the Voting Place for said Voting Precinct No. 9.

#### **4) DIVISION OF EXISTING VOTING PRECINCTS TO CREATE AN ADDITIONAL, NEW VOTING PRECINCT AND DESIGNATION OF VOTING LOCATION FOR THE NEWLY CREATED VOTING PRECINCT**

**a)** Authorize the division of Baldwin County Voting Precinct No. 20 (Daphne, Lake Forest), said division creating a new Baldwin County Voting Precinct No. 8 (Daphne, Lake Forest North) and designating St. Paul's Episcopal Church, located at 28788 North Main Street, Daphne, Alabama, as the Voting Place for said new Voting Precinct No. 8.

*[Current Precinct No. 20 will be split by Ridgewood Drive north/south with the north portion being designated as a new Precinct No. 8 and the rest of the precinct remaining as Precinct No. 20.]*

**b)** Authorize the division of Baldwin County Voting Precinct No. 42 (Fairhope, Downtown), said division creating a new Baldwin County Voting Precinct No. 52 (Fairhope, Downtown South) and designating First Fairhope Baptist Church, located at 300 South Section Street, Fairhope, Alabama, as the Voting Place for said new Voting Precinct No. 52.

*[Current Precinct No. 42 will be split by Fairhope Avenue north/south with the south portion being designated as a new Precinct No. 52 and the rest of the precinct remaining as Precinct No. 42. The Fairhope Civic Center will remain as the polling place for Precinct No. 42.]*

**c)** Authorize the division of Baldwin County Voting Precinct No. 47 (Foley, Downtown), said division creating a new Baldwin County Voting Precinct No. 3 (Foley, Downtown South) and designating St. Margaret of Scotland Parish, located at 601 W Laurel Avenue, Foley, Alabama, as the Voting Place for said new Voting Precinct No. 3.

*[Current Precinct No. 47 will be split by Highway 98 north/south with the south portion being designated as a new Precinct No. 3 and the rest of the precinct remaining as Precinct No. 47. The Foley United Methodist Church will remain as the polling place for Precinct No. 47.]*

#### **5) RELOCATION OF VOTING PLACE**

**a)** Relocate the Voting Place for Baldwin County Voting Precinct No. 20 (Daphne, Lake Forest South) from the Daphne High School Trojan Hall to the Eastern Shore Baptist Church, located at 6847 Park Drive, Daphne, Alabama.

New voting cards will be mailed to the affected registered voters of the voting precinct listed above.
